Your application for a visit visa to the United Kingdom has been refused.

How your application was considered

In deciding whether you meet the requirements of Appendix V: Immigration Rules for visitors (https://www.gov.uk/government/collections/immigration-rules), I have considered:

- · your application, and any additional relevant information you have provided with it
- · your immigration history

The decision

I have refused your application for a visit visa because I am not satisfied that you meet the requirements of paragraph(s) V4.2, of Appendix V: Immigration Rules for Visitors because:

- You have applied for a leave to enter to visit the UK for 14 days for tourism
- I have considered the information you have provided about your personal and economic circumstances. In your application you state that you are employed as Asia development manager for TNG Europe Ltd. and that you earn 10,000RMB (£1000 @ exchange rate of £1=10RMB) per month. You also state that you receive £5000 per month from your savings and investments. In support of your application you have provided a bank statement in your name with account number ending 7858. This statement does not demonstrate that your income is as stated in your application. I note that you have provided an employment certificate from the UK and a statement that you work from home, however I am not satisfied that you are employed as stated in your application. I am therefore not satisfied that you are a genuine visitor and will leave the UK at the end of your visit. Your application for a visit visa has been refused under paragraph V4.2(a) and (c)
- In support of your application you have provided a bank statement in your name with account number ending 7858. As stated previously, I am not satisfied that your income is as stated in your application because this statement does not demonstrate your salary. I note that in April 2016 there are deposits totalling 58,000RMB (£5800). You state that you transferred a total of 50,000RMB (£5000) from your Alipay account on 25/04/2016, but the documents you have provided do not demonstrate the origin of these funds. I am not satisfied that they are genuinely available for your personal use. I am therefore not satisfied that you have sufficient funds

available to cover your costs whilst in the UK without working or accessing public funds. Your application has been refused under paragraph V4.2(e)

You have stated that your travel, maintenance and accommodation costs will be met by TNG Europe Ltd. However, as previously stated, because the documents you have provided do not demonstrate your stated income, I am not satisfied that you are employed as stated in your application and I am therefore not satisfied that your sponsor has a genuine professional or personal relationship with you and that your sponsor can and will provide you with support for the intended duration of your stay. Your application for a visit visa has therefore been refused under paragraph V4.3 (a) and (c).

Future Applications

Any future UK visa applications you make will be considered on their individual merits, however you are likely to be refused unless:

- your personal circumstances change significantly between now and your next application
- you provide compelling new evidence with your next application.

In relation to this decision there is no right of appeal or right to administrative review.
