- 1. 本保险保障地域范围为台湾。Territorial Coverage is Taiwan.
- 1. 不除壓條時速%范围为日海。feltinitial Coverage is Talwaii.
 2. 在入台相关证件有效期内,如被保险人推迟入台,则被保险人保险凭证所载生效日将自动变更为被保险人在保险期间内离开其经常居住地或日常工作地直接前往旅行目的地的时间。被保险人需要救援/理赔服务时,需要提供全部相关出入台证明复印件,否则,保险人有权拒绝救援/理赔服务。其它不符合上述约定的生效日变更仍需根据条款约定提前通知保险人。During the period of visa validity, the inception date of insurance policy (or insurance certificate) will automatically update to while the insured leaving his/her regular residence to the trip destination if the insured postpones the trip. All scanned copy of passports and entry permit of ROC are prerequisite when the insured asks for assistance or files claim, otherwise, the insurer remains the right to decline the service. The insurd should inform the insurer of any other effective date change in advance except for the above.

Diving refers to underwater activities with diving depth no more than 18 meters in the river, lake, reservoir, sea and/or canal.
- 4. 18周岁以下的未成年人身故保险金额以保险事故发生时中国保监会规定的未成年人身故保险金额的相应限额为限。Any insured under 18 years old, the death benefit paid to the insured shall not exceed the limit as specified by China Insurance Regulatory Commission.
- 5. 本保险的投保年龄上限为80周岁, 70岁以上被保险人保险金额不变。The insured persons must be under 80 years old under application, The benefit paid to the insured above 70 years old will be unchanged.
- 6. 如保险期间为一年,每次承保旅行最长期限为90天。The maximum period of each insured trip is 90 days if insurance period is one year.
- 7. 本保险为短期旅行保险,保险合同一旦生效,投保人与保险人均不得解除本保险合同。 This insurance is for short-term travel. Once the insurance contract goes into effect, neither the insured nor the insurer shall terminate it.
